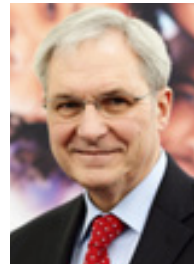

CHANGING THE FUTURE ONE FAMILY AT A TIME



Jason Michaels and his daughter Carly have made a good start on the path to a better life. They are able to enjoy a more stable home because of the support they received from Judson Center's Visitation Coaching program and Jason's commitment to being a good parent.

Carly had been staying with family members while Jason confronted his drug addiction which stood in the way of his being the kind of parent that she deserved and that he wanted to be. Although Jason had never parented before, he wanted to learn how to be a good parent. With this in mind, he committed himself to his sobriety.

When it was time for Carly to rejoin her father, a Judson Center social worker was there to ensure an easy transition. She helped Jason set appropriate goals which included to obtain and maintain employment, establish a suitable home, and learn parenting skills. Then she helped him work toward these objectives. Jason was especially eager to develop an understanding of his daughter's developmental needs and how he could best parent her. He was able to complete the program early. Initially it was expected that he would receive support for four months. He achieved his goals in only two.

Jason was always open to guidance prompts and modeling from his social worker as she observed his interactions with his daughter. He always had lots of questions as he worked to be the best parent he could be. He learned to help Carly with the difficult feelings she had due to their ten-month separation. He also learned about age-appropriate physical and emotional development; some of this made additionally challenging by Carly's physical disability. He eventually was able to put structure in their life with family rules and routines around school, homework and hygiene.

While Jason worked on his parenting skills he was also busy attending to his sobriety. In addition to going to Narcotics Anonymous meetings three times a week, he was inspired to start a substance abuse group which he leads weekly. He is proud to be able to take a leadership role in helping others.

All this hard work is paying off. Although she always looked up to her father, Carly's bond with him is stronger than before. As a result, Jason has greater confidence as a father and can see the positive results of his accomplishments. He told his social worker, "Today I finally feel like Carly and I are going to be just fine."

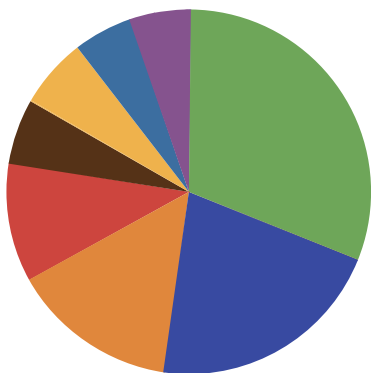

DISABILITY SERVICES

SUPPORTED INDEPENDENCE AND GROUP HOMES allow adults with developmental disabilities to live in the community with the appropriate supports.

VOCATIONAL SERVICES program helps adults with disabilities obtain and maintain gainful employment in the community; enhancing their degree of independence, personal choice, and community involvement and contribution.

RESPIRE CARE homes were designed for children with disabilities to stay for short periods of time in order to give the parents and caregivers time to recharge or to tend to other pressing needs within the family.



CHANGING LIVES IN 2012 PROGRAM OUTCOMES

Judson Center provided life improving services to **4,022** children and families in need through the year and these four centers of excellence:

AUTISM

- **370** children on the autism spectrum developed new social and life skills

BEHAVIORAL / MENTAL HEALTH

- **435** individuals received mental health counseling

CHILD WELFARE

- **98** children were matched with a forever family through our adoption program
- **1,730** difficult to place youth participated in the Michigan Adoption Resource Exchange - an information and referral service for families interested in adopting from foster care.
- **128** foster children were safely tucked into bed for **22,768** days of care
- **48** youth received intensive psychiatric services through our residential program and learned valuable skills to help them regulate their emotions and keep them safe during crisis
- **846** families at risk of having their children removed remained together or were reunited after a brief separation

DISABILITY SERVICES

- **52** adults with disabilities were able to live as independently as possible
- **128** adults with disabilities were given the chance to work in the community
- **187** families received **4,056** days of loving respite care for a family member with a disability

2012 PROGRAM HIGHLIGHTS

- In response to the increasing need for more treatment options for individuals with co-occurring mental health and substance abuse disorders, Judson Center therapists are receiving additional education. The Flinn Foundation has made it possible for Judson Center to train our therapists in Motivational Interviewing (MI) which is recognized as a best practice treatment. MI is a collaborative conversation to strengthen a person's own motivation for and commitment to change.



- In an effort to expand the number of foster families, the Foster Care Navigators Program has been established. The goal of the program is to support the recruiting, retaining and encouragement of great people to become wonderful foster parents. Help is available from pre-application information through licensing to smooth any obstacles that may arise.

- Judson Center has opened two Post Adoption Resource Centers serving 23 Michigan counties. The centers address the needs of families who have adopted a child from the child welfare system. Understanding that there are issues, including loss and trauma, that are unique to these adopted children and their families guides the work of the PARC staff. Families receive support tailored to their specific needs.
