- Child Support Payments (if applicable)

- Food or Cash Assistance (if applicable)
- Section 8 or HUD Housing Documentation (if applicable)
- Any Other Income (must be claimed on taxes)
- Copy of Driver's License
- Vehicle Registration
- Gun Registration (if applicable)
- Copy of CCW/CPL License (if applicable)
- Proof of Auto Insurance
- Copy of Marriage License (if applicable)
- Divorce Decree (if applicable)
- Copy of Rental Agreement or Mortgage Statement
- Most Recent Utility Bills:
